## Title I Parent Involvement Policy

### **PART I. GENERAL EXPECTATIONS**

**EOF** agrees to implement the following statutory requirements:

*(C) that parents are full partners in their child’s education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*

*(D) the carrying out of other activities, such as those described in section 1118 of the ESEA.*

- **End of term course completion reports**

- B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
- **Family Social/Academic Nights**
  - **On-line learning system such as: IXL Math, Study Island, A+**
- C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
- **Family Social/Academic Nights**
  - **Parent Liaison**
  - **Ongoing Parent Meetings**
- D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
- **Family Social/Academic Nights**
  - **Student Recognition Events**
  - **Academic Achievement Events**
  - **Classroom Specific Events**
  - **Open House**
  - **Holiday Community Events**
- E. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
- **School-wide communication sent home in multiple languages**
  - **Automated phone messages**
  - **Availability of multiple language translators**
  - **School website**
  - **Parent electronic access to student grades and attendance**

### **PART III. DISCRETIONARY DISTRICT WIDE PARENTAL INVOLVEMENT POLICY COMPONENTS**
